What is Payroll Giving?

Payroll Giving is the easiest, most tax-efficient way to donate to EACH. As your donations are made before tax, your chosen charity receives even more!

For example, if you are a basic taxpayer (20%), the charity receives £10 but you only pay £8 and HMRC pay £2. Or if you are a higher rate taxpayer (40%), the charity receives £10, you only pay £6 and HMRC pays £4.

What are the benefits to you?

- A tax-free way for you to give to charity
- A quick and easy way to donate
- You can donate to EACH and any other charities of your choice There
- is no limit on the size of gift.

Signing up for Payroll Giving is easy

Contact your HR department and complete a simple form to say which charity you want to support and how much you want to give every pay day. You can choose one or multiple charities. Your employer deducts the donation from your salary before tax on a monthly basis, and forwards it to the Payroll Giving agency, who deposit the entire amount into the charity's account. That's it!

Why support EACH?

EACH cares for local children and young people with life-threatening conditions at an unimaginably difficult time. For families accessing our care and those who have been bereaved, EACH is their lifeline. When time is short, your donations will help families make the most of their precious time together and create memories that last forever.

Lola's story (read the full story on our website)

The Morris family's journey with EACH began in June 2016 when their daughter Aneira sadly died at just 26 days old due to major organ failure. EACH stepped in to support them with counselling and helped them create precious keepsakes, such as a pendant necklace with Aneira's fingerprint. On this support mum Sonia says "Without EACH I feel like we wouldn't have any memories of Aneira ... I feel like we have part of Aneira with us because of what EACH did"

Just over a year later when their third child Lola was born, it quickly became clear she was suffering from Chronic Liver Failure and was taken to London's King's College Hospital for an operation just days later. She was later diagnosed with TTC7A, relating to low immunity and bowel issues, making her one of seven worldwide. She now has various medical requirements and has to be connected to a machine 18 hours a day, with a six-hour break in the daytime.

The Morris family have received a variety of support from EACH and say that they would be "lost without EACH". "When we go to any events run by EACH, the staff are so welcoming, they know you and your family, they'll always just help you, talk to you and be there for you"



Benefits to children and families

Just £10 a month each year could fund an EACH nurse for **one whole day**, providing expert nursing care to children and young people.

£5 a month each year could help pay for an EACH Play Specialist to visit children at home or spend time with them during their stay at the hospice, supporting them in play tailored to their individual needs.

£18 could go towards an hour of specialist therapy every month, like art and music, to help children with a fun and creative way of self-expression.
