

East Anglia's Children's Hospices (EACH) Great Eastern Run Terms & Conditions

Please read these terms and conditions carefully and make sure that you understand them before completing your registration. You should understand that by submitting your registration form for your place in the Great Eastern Run, you agree to be bound by these terms for yourself and all those you are registering.

Participation

- I acknowledge that I am participating in this event at my own risk and my participation will be subject to the race organiser's, Good Running Events, terms and conditions, which can be found on their website [Great Eastern Run - 11th October 2026](#). EACH accepts no liability for the organisation or management of the event.
- By paying a registration fee of **£15pp** to EACH I am securing my charity place and acknowledge that the registration fee is non-refundable.
- I understand that my place will only be secured once I have paid the non-refundable registration fee.
- I understand that I cannot swap, sell or transfer my place in the Great Eastern Run, or allow anyone else to participate on my behalf. EACH has a limited number of places available and are filled on a first come first serve basis.
- I will inform EACH immediately if I am unable to take part in the Great Eastern Run by emailing events@each.org.uk or calling 01223 800807. Registration fees and sponsorship raised are non-refundable. Deferrals are not guaranteed and will be considered on a case-by-case basis, subject to availability, fundraising progress, and the policies of the event organiser. Places may only be deferred once and for a maximum of one year.
- I acknowledge that the minimum age for entry is 17 years old. If you are under the age of 18 on the date of the event, you will require permission from a parent or guardian to complete registration.
- EACH is proud to say we have a zero-tolerance policy for bullying and harassment. Please ensure you treat our staff, volunteers, event organisers, other participants and passers-by with the same respect you would expect to receive.
- While taking part in the Great Eastern Run and associated fundraising activities, all participants act as representatives of EACH and are expected to behave in a manner that reflects positively on the charity at all times.
- EACH reserves the right to refuse an application or withdraw a participant's charity place at its discretion if these terms and conditions are breached or if the participant's behaviour is deemed to bring EACH into disrepute. No refund will be provided in such circumstances.

Sponsorship

- All participants pledge to raise a minimum of £250 in sponsorship for EACH (excluding Gift Aid and the registration fee) through participation in this event.
- By participating I agree to return all sponsorship with accompanying sponsorship forms to EACH within 6 weeks following the event date. Please note that all online money donated to your online fundraising page will automatically be transferred to EACH and doesn't need to be sent to us after the event.
- Funds raised by participating in this event in support of EACH are raised for the sole purpose and benefit of EACH (registered charity no. 1069284) and those who receive the support from its services.
- Participants understand and accept that EACH may terminate your rights to raise funds at any time, if they feel you are in breach of the [Fundraising Code of Practice](#), particularly, but not limited to, behaviour when fundraising. Your fundraising must be legal, open, honest and respectful.
- Participants must not misrepresent how funds raised will be used by EACH. If unsure about appropriate messaging or need guidance, you should contact the EACH fundraising team for support.
- All sponsorship and donations raised in support of EACH are non-refundable, including in the event of injury, illness, withdrawal, or inability to take part in or complete the event.
- I will speak with EACH about using the EACH branding and logo before producing any materials to promote my running challenge. Any materials used (e.g. collection buckets) following the completion of the event will be returned within six weeks following the event date.

Personal Data & Images

- I give permission for EACH to use any images, video or feedback taken in relation to the Great Eastern Run, to be used by EACH in the promotion or advertising of future activities. If I do not wish for this to happen I will inform EACH in writing.
- I give permission for my personal information to be securely stored and used by EACH in relation to the organisation, stewardship and administration of the Great Eastern Run.
- I understand that EACH may need to share my personal data with the event organiser, Good Running Events, in order to complete my registration. Failure to complete the organiser's registration process by the specified deadline may result in the loss of my place without refund.
- Your information is held securely with all reasonable precautions used to protect it. Your data may also be used for profiling to help us provide the best service possible. We will only allow your information to be used by suppliers working on our behalf and will only share it elsewhere if required to do so by law. Health & safety

- I will comply with any health and safety guidelines and rules issued by EACH and the Great Eastern Run organisers, Good Running Events.
- EACH is not responsible for providing any guidance for your training for this event. By registering for this event it is assumed that you will undertake the necessary training to successfully participate and seek any medical advice to ensure that you are fit, capable, and healthy to take part. We recommend that you consult a doctor or other healthcare professional before registering.
- If I sustain an injury or become unwell prior to the event, I will inform EACH as soon as possible. I understand that I should not take part in the Great Eastern Run unless I am medically fit to do so.
- I understand that I take on this running challenge at my own risk and EACH accepts no liability for any losses, damages, injury or death resulting from my taking on this challenge.

Dates, changes and terminations

- Please note that this agreement is valid from the date your place is purchased through to 28 days following completion of the Great Eastern Run.
- I understand that the Great Eastern Run is organised by a third party organisation, Good Running Events, who are solely responsible for its operational running. Any changes to the run are beyond the control of EACH.
- I understand that should the Great Eastern Run be postponed or cancelled, EACH will endeavour to secure a deferral to a future event where possible; however, deferrals are not guaranteed and are subject to availability and the policies of the event organiser.
- EACH reserves the right to update its terms and conditions in relation to the Great Eastern Run at any time prior to the event. All participants will be provided with any updated terms and conditions in advance of the event.
